The Time & Tide Bell Organisation and Tania Kovats reserve the right to refuse use of submitted content if it does not comply with these Terms & Conditions.

Creating Your Content for Submission to COTIDAL

Content Creators do not need expensive, professional equipment. Good quality films or audio can be made with inexpensive equipment including mobile phones and tablets.

1) Submitted Content MUST be:

a) Suitable for family viewing

2) Submitted Content MUST NOT be:

a) Deemed to be offensive or defamatory towards any person or organisation

3) Copyright:

- a) The Content Creator(s) MUST own the sole and legal copyright to the submitted content and agree to its use in the promotion, production and distribution of the COTIDAL project.
- b) If the Content Creator(s) DO NOT own sole and legal copyright to the submitted content, they MUST secure written confirmation and permission for any content used in their submitted content.
- 4) **Consent and Permissions:** Consent is needed for all submitted content. Anyone who appears in or whose voice is used in the submitted content must give their written permission to the Content Creator(s). An appropriate adult (parent, guardian, carer) must give authority for contributors under the age of 16.
- 5) **Health & Safety**: The Content Creator(s) is/are responsible for their own health & safety and associated risks whilst creating content.
- 6) **Environment**: Content Creator(s) must treat the landscape and environment including animals and plants with respect and avoid causing any damage or injury.
- 7) **Landowner Permission**: Whilst creating content, please consider if you require permission from the landowner. Permission must be obtained for recording (video, photographs, sound) on private land.
- 8) **Drone Use**: If you create or use existing drone footage please ensure you have the appropriate permissions in place and that all content creation is both legal and safe.
- 9) **Music:** Permission must be obtained for all music used. Content Creator(s) can not use music downloaded from the internet without permission from the owners and those who hold the rights to the music.

Please note that neither The Time & Tide Bell Organisation or Tania Kovats hold responsibility for Content Creator(s) activity or safety during the making of their content.

Submitting Your Content for Inclusion in COTIDAL

- 1) The Content Creator(s) who created and own the copyright(s) to the submitted content:
 - a) agree to allow the content to be used by the Time & Tide Bell Organisation and Tania Kovats as part of the COTIDAL project
 - b) confirm that they own the sole and legal copyright to the submitted content and hereby agree to its use in the promotion, production and distribution
 - c) confirm that the submitted content is made voluntarily and the Content Creator(s) accept that no fee will be paid to them for their contribution today or in the future.
- 2) The Content Creator(s) agree and consent that the Time & Tide Bell Organisation and Tania Kovats may:
 - a) Use any moving image, still photo or audio recording from the content submitted
 - b) Submitted content may be edited and used in COTIDAL films or for any associated publicity materials including print, DVD, online including social media.
 - c) Consent is given by the Content Creator(s) without limitations for any use by projection, playback, broadcast or publication, including via the internet, in any part of the world
 - d) The Content Creator(s) agree that this contribution is made voluntarily and accept that no fee will be paid for their contribution today or for future distribution of the resulting moving images, photographs, audio recordings or completed film
 - e) The Content Creator(s) agree that copies of their submitted material(s) shall be and remain the property of Time & Tide Bell Organisation and Tania Kovats. All content will be stored safely in full compliance with current GDPR guidelines.
- 3) Please create and submit content wherever possible in the following format:
 - a) Video: Landscape (horizontal), MP4, 30 frames / second, high resolution
 - b) Audio: MP3
 - c) Still Image: Landscape (horizontal), as high resolution as possible, 300 dpi or over
